USEF MEMBERSHIP STATEMENT:

LIFE, SENIOR ACTIVE AND JUNIOR ACTIVE MEMBERS SHALL BE ELIGIBLE TO PARTICIPATE IN ALL CLASSES AT REGULAR COMPETITIONS, EVENTING COMPETITIONS AT THE PRELIMINARY LEVEL OR ABOVE AND COMBINED DRIVING COMPETITIONS AT THE ADVANCED LEVEL, DRESSAGE, REINING AND VAULTING COMPETITIONS AND ENDURANCE RIDES. A NON-MEMBER MAY PARTICIPATE AS A HANDLER, RIDER, DRIVER, OWNER, LESSEE, AGENT, COACH OR TRAINER AT REGULAR COMPETITIONS, EVENTING COMPETITIONS, DRESSAGE COMPETITIONS, REINING COMPETITIONS AND COMBINED DRIVING COMPETITIONS UPON PAYMENT OF A \$30.00 NON-MEMBER REGISTRATION FEE. PARTICIPANTS IN THE FOLLOWING CLASSES ARE EXEMPTED FROM THE REQUIREMENTS OF THIS RULE: 1) LEADLINE; 2) EXHIBITIONS; 3) GAMES AND RACES; 4) CLASSES FOR 4-H MEMBERS; 5) WALK-TROT AND ACADEMY CLASSES (Academy classes are classes limited to horses used regularly in a lesson program.); 6) USDF INTRODUCTORY LEVEL TESTS, PAS DE DEUX AND QUADRILLE CLASSES; 7) NRHA ENDORSED REINING COMPETITIONS; 8) OPPORTUNITY CLASSES; 9) CITIZENS OF OTHER NATIONS WHO HAVE PROOF, IN ENGLISH, OF CURRENT MEMBERSHIP IN GOOD STANDING OF THEIR OWN NATIONAL FEDERATION; 10) USEA BEGINNER NOVICE DIVISION AND 11) ASSISTANT HANDLERS IN DRESSAGE SPORT HORSE BREEDING CLASSES.

A copy of the appropriate, current Federation membership card(s) must be sent with entries.

USEF RULES: This horse show will be conducted in accordance with the rules of USEF, Chapter AR – Arabian, Half-Arabian and Anglo-Arabian Division. The official Rulebook of USEF will prevail for this show. This premium list is based on rules in the current Rulebook. Any changes or correction of rules will automatically become a part of this Premium List. Each participant in this show is responsible for a knowledge of and is subject to the USEF Rulebook and the show will be conducted and judged in accordance therewith. Exhibitors are encouraged to fully read all specifications for classes they plan to enter, including those governing appointments. Questions not covered by USEF Rules will be decided by Show Management and such decisions will be final.

ABUSIVE TREATMENT: Any action that may inflict pain on any horse in a stall, runway, schooling area, show ring or elsewhere on the Kansas Coliseum grounds before or during the show constitutes a violation and renders offenders subject to penalty by USEF, AHA, and/or the Show Committee. Any horse being shown in halter or performance that has whip marks in evidence must be excused from the class by the judge. Horses showing signs of undue stress, inhumane treatment, or whip marks must be penalized. Excessive use of whip or device on any horse outside the show ring shall not be tolerated and grounds shall be monitored for any such action.

ADMISSION TO THE RING: No person will be permitted to enter the ring except participants in the class, judges, their assistants and show officials. Attendants and grooms may enter the ring only when summoned by order of the judge and must be neatly and properly attired.

AGE OF HORSE: For horse show purposes any horse shall be considered to be one year old on the first day of January following the actual date of foaling. Champions and Reserve Champions must be at least two years old, except for geldings and Junior Champions and Reserve Junior Champions.

ALCOHOLIC BEVERAGES: Shall not be served to persons under 21 years of age. The host shall be held responsible as required by law. Every person who sells, furnishes, gives or causes to be sold, furnished or given away any alcoholic beverage to any person under the age of 21 is guilty of a misdemeanor.

AMATEUR CERTIFICATION: Every person who has reached their 18th birthday and competes in classes for amateurs under Federation rules must possess current amateur certification issued by the Federation. USEF GR808 & GR809. Certification must be available for inspection or the competitor must have lodged with the Competition Secretary, at least one hour prior to such class, an application for such certification provided by the Federation.

AMATEUR OWNERS: Combined ownership is not permitted in Amateur Owner classes unless all owners are members of the same family. Leased horses are not eligible.

ARENA: The footings for main show arena and warm-up arena consist of dirt. The main show arena is 100 feet by 200 feet. The warm-up arena is 120 feet by 240 feet.

ARENA PRACTICE TIMES: The main show arena will be available, for short periods, several times during the show. A separate practice and warm-up arena will be available at all times the show is in session, except for possible short maintenance periods. (Only horses entered in the show may use the arenas). All arenas will be closed at 12:00 midnight each night. Night lights only after 12:00 midnight each night.

ARTIFICIAL APPLIANCES: Horses must be shown without artificial appliances which includes tongue ties and/or mouth ties, see USEF, AR101. Gag bit are prohibited (Exception: Jumper classes). Action produced by artificial methods shall be penalized. The use of chains, rollers or similar devices on the show grounds during or before a show is prohibited and the show committee shall bar violators from further participation for the remainder of the show, and they shall forfeit all entry fees and winnings for the entire show.

BREEDING AND HALTER CLASSES Subchapter AR-2 HA/AA Breeding and Halter Classes: Saddle type horses should display the conformation qualities necessary for Saddle Seat English type events. Pleasure type horses should display the conformation qualities necessary for any pleasure type event. Stock type horses should display the type of conformation qualities necessary for western events. Hunter type horses should display the conformation qualities necessary for all hunter seat shows. Futurity Classes are local unrated classes. These classes are run under the same specifications as USEF rated classes. They are not qualifying classes for any Championship.

CAMPER AND MOBILE HOME SPACE: State Fire and Coliseum Regulations PROHIBIT any vehicles being plugged into the pavilion or arena facilities. This will be strictly enforced. Full service hook-up trailer spaces located south of Pavilion I can be rented on a reservation system by contacting the Kansas Coliseum. Phone 316-755-7328. Limited space is available. An electric outlet is provided – no dumping facilities are available.

CANCELLATION OF CLASSES: The Show Management reserves the right to cancel or combine any classes or make any scheduling changes for the betterment of the show. Schedule changes will comply with USEF Rule Book.

CHAMPIONSHIPS: All first, second, and third place winners in qualifying classes are required to enter the championship, exhibitors must fill out and sign the official entry form in the office for these classes.

CLASS CALLS AND TIME LIMITS: Every effort will be made to maintain a working public address system. The public address system and paddock calls must be considered a courtesy. It is the responsibility of the exhibitor to be at the gate at the appropriate time. As the first horse enters the in-gate, a two minute time rule shall be enforced. Exhibitors should notify the ring announcer AND gate personnel if a tack change is required or the exhibitor is not planning on entering the ring. Should a horse not make the gate, NO REFUNDS WILL BE MADE.

CONCESSION STAND: Concessions will be available on the grounds.

CONDITIONS OF ENTRIES: All entries, except entries in equitation and showmanship classes (See AR207.7 & AR216.2), must be serviceably sound. All entries must be in good condition. Horses will loss of sight in one eye may compete in performance classes only. Horses must wear a long, natural, unbraided, unset, ungingered tail (Exception: Horses shown under Hunter, Show Hack or Dressage appointments are permitted to show with a braided mane and tail, and cutting horses with a roached mane). The use of glitter on or in the mane, tail, hair or hooves is prohibited.

COURTESY: Any discourteous act on the part of any owner, exhibitor, groom, trainer, or agent made toward judges, official or staff will disqualify their entry and forfeit all fees and premiums. The Horse Show Committee shall have full power to act in issuing a ruling in such cases. Should the act justify it, the Horse Show Committee shall have power to exclude the offender(s) from competition and remove them from the show grounds without being held liable for damages of any kind and this shall be accepted as a condition of the entry.

DISCIPLINE: Exhibitors are warned that any act of discourtesy or disobedience to the officials of this show on the part of the owner, lessee, trainer, groom, rider or driver will disqualify the horse from adjudication. The management reserves the right to remove a horse, owner, lessee, trainer, groom, rider or driver from the show without being liable for compensation or damages.

DISQUALIFICATIONS: Refer to USEF Rule Book GR116, GR1216, GR1502. Any horse doctored in any way, artificially, improperly or unfairly prepared or tampered with before entering the show ring will be disqualified. If it is ascertained that any exhibitor has made or caused to be made, any false statements on any entry blank in regard to any animal exhibited, or if any exhibitor shall attempt to interfere with the judges in the performance of their duties, he or she shall be excluded from competing or exhibiting. In case of any animal being disqualified, the winner of the next succeeding prize in the class shall take the prize that has been awarded to such disqualified animal and the lowest moneyed prize in the class shall go to the reserve number.

DRUGS AND MEDICATIONS: A testing fee of \$12.00 for each horse entered in the show will be assessed in accordance with USEF Rules.

New Rule effective 2/1/05, AR101.5 which allows for testing of ginger, capsaicin and other irritants.

ELECTRICAL AND FIRE REGULATIONS: All electrical installations and connections must meet state and county codes. Aisles must be maintained clear for a minimum of six feet wide and eight vertically. No obstructions or projections shall be allowed in aisles. No Class 1 flammable liquids shall be allowed in the buildings.

ELECTRONIC COMMUNICATION DEVICES: Such devices used for the purpose of coaching, etc. between competitors and individuals outside the ring shall be prohibited in all classes in this show. Handicapped riders who have submitted written proof to the USEF Steward may be exempt from this rule.

EMERGENCY PHONE: During the show, the horse show office phone is 316-755-2560. The Kansas Coliseum office phone is 316-660-1000 ext # 3. The Sedgwick County Sheriff's Office phone is 316-382-7264.

Late Entries after March 12 will be accepted with a late charge of \$35.00 per horse. Entries will be accepted on a "First Come, First Served" basis according to the availability of stabling. Any horse entered in the show may enter additional classes without any penalty.

The deadline for entering additional classes is 1 hour prior to the start of the session. Entries must be made under full registered name and a copy of registration paper must accompany the entry. Also send a copy of the USEF and AHA membership cards for the owner, trainer, driver, rider or halter handler. The same applies to youth (17 & under) members. If the recorded owner of a horse is listed as a farm, ranch syndicate or corporation, then the entry must have a current Farm/Ranch membership with AHA. Any owner, trainer, driver, driver, rider or handler who exhibits horses in the show ring or signs the entry form as a responsible person for any individual's horses at the show must be a member of AHA or pay an additional fee of \$10.00. Entry Forms must be filled out completely. Owners, Trainers and each rider/driver/handler must sign. If owner is the trainer, sign in both places. Should the exhibitor have any past due indebtedness to KAHS, monies submitted with entries will be applied first to that indebtedness. **THE MANAGEMENT RESERVES THE RIGHT TO REJECT ENTIRELY OR ACCEPT CONDITIONALLY ANY ENTRY OR APPLICATION TO THIS COMPETITION WITHOUT BEING LIABLE FOR COMPENSATION.** Please review all rules and make entries carefully. No numbers will be given if entries are not complete. No credit will be given for switching classes.

A TRAINER IS A PERSON WHO HAS THE RESPONSIBILITY FOR THE CARE, TRAINING, CUSTODY AND/OR PERFORMANCE OF THE HORSE FOR THE CARE, TRAINING, CUSTODY AND/OR PERFORMANCE OF THE HORSE. SIGNATURES ON THE ENTRY FORM INDICATE ACCEPTANCE OF ALL USEF, AHA, AND THE KANSAS ARABIAN HORSE SOCIETY, INC. RULES. In case the exhibitor, rider, driver or handler is under the age of 18, his/her parent or guardian, or if not available, the trainer, must sign an entry blank on the minor's behalf.

ENTRIES AFTER THE CLOSING DATE: Management reserves the right at its sole discretion to accept or solicit entries after the closing date when deemed necessary to insure the success of the show.

ENTRIES CLOSE: Entries close March 12. Entries must be postmarked by that date. After that date, a late entry fee is applicable. Post entries will be accepted. Equitation and Championship Classes are excluded from late penalty. Post entries must be made by 1 hour prior to the start of the session.

EXHIBITOR SPONSORED PARTIES: No Achievement Award or exhibitor celebration may begin before the end of a given performance session of the show. All celebrations must end before midnight and they all must be cleared through show management.

FARRIER: A farrier will be available during each show session. Exhibitors are responsible directly to him for their services and method of payment.

FEED AND BEDDING: No feed is available. Bedding is not included in the stall fees. Shavings will be available with terms cash on delivery. If you wish shavings to be at your stall upon arrival, please call 785-366-0226. Leave message. Shavings must be pre-paid and your message will be confirmed.

FEES: All fees, including entry and nominating fees, must be paid in full and accompany entry forms. No post dated checks will be accepted. There will be no charging of entries, stall, or other fees. During the show, an open check may be left in the office for additional entry fees and charges made during the show. A \$30.00 fee will be charged for all returned checks. If a returned check has not been taken care of two (2) weeks after notification, your name will be submitted to USEF.

FIRST AID: First Aid treatment will be available at all times during performances.

HEALTH REQUIREMENT: All horses admitted to the grounds must have a Health Certificate issued within the last 30 days with an EIA (coggins) test done within the last 12 months. Note, the EIA test information must be completely recorded on the health certificate. Have a copy of the EIA test record attached. Health Certificates are to be presented to the show secretary upon arrival.

HORSES: Only horses entered in the show may be exercised or worked on the grounds. Show management may allow exceptions

ARABIAN HORSE ASSOCIATION (AHA): Each participant must be a member of the Arabian Horse Association (AHA) or pay a \$10.00 single event fee per horse. This includes the rider, driver, handler, trainer, and owner, i.e., individual, farm, partnership or syndicate.

JOTR QUALIFICATION ELECTION FROM JTR CLASSES: JTR classes at this show will qualify a youth for either JOTR or JTR classes at Regionals or Youth National shows as stated in the new AHA rule: "JOTR riders may assign or designate their qualification for Youth National and Regional Championship shows from a JTR class provided the same JOTR class is not offered in that discipline at that show." No written designation is required.

JUDGES: If for any reason a judge fails to attend this show or perform his duties, the Show Committee reserves the right to substitute a judge for the one who is officially designated in the Premium List in accordance with USEF Rule GR1213. It is a violation of USEF Rules to commit any act or make remarks during the show that are considered offensive and/or made with the intent to influence or cast aspersions on the judging. Judge System: Single – All classes will be judged by one judge and the judge's placing shall prevail.

JUNIOR HORSE: A Junior Horse is one that is 5 years old or under as of January 1st.

LIABILITY: The Kansas Arabian Horse Society, Inc., its officials and the Kansas Coliseum will not be responsible for any loss, personal injury or damage to any horse exhibited, or for any article of any kind or nature that may be occasioned to any person or any horse owned or exhibited by him and shall indemnify the Management against all legally established claims or damages of any kind or nature that may grow out of any injury occasioned by any horse owned or exhibited by him, or arise from negligence of the person in charge of any such horse. The submitting of any entry form to the Show Secretary shall constitute an acceptance of each person signing same of the provisions herein set forth. All entries are accepted with the understanding that the Kansas Arabian Horse Society, Sedgwick County and the Kansas Coliseum shall not be responsible for any loss or damage or injury to horses exhibited or any article of any kind or nature that may be lost or destroyed or in any way injured. All horses shall be under the control and direction of the Show Committee but solely at the risk of the exhibitor, who will be responsible for any loss, damage or injury to any person, animal or property occasioned by him, his agents or employees or by an animal owned or exhibited by him, and shall indemnify the aforementioned against any and all loss, damages, and liability thus occasioned, including but not limited to any and all legal costs, including attorney fees, which may be incurred as a result thereof. The submission of a signed entry form to the Show Committee constitutes an acceptance of the provisions herein set forth.

LIBERTY CLASSES: Limited to 10 horses, first come, first entered basis.

LIMIT HORSE/RIDER: A Limit Horse/Rider class is open to horses/riders that have not won six (6) first place ribbons at Regular Member Shows of USEF or the Canadian Equestrian Federation in the particular performance division in which they are shown. A Limit entry is such from the date of the closing of entries for this show.

LOCATION OF SHOW The Kansas Coliseum, the Midwest's multipurpose showplace, is ready for you! Located north of Wichita on I-135, the Kansas Coliseum is just ten minutes from downtown Wichita's hotel district and 15 minutes from Wichita's Mid-Continent Airport. Newton is approximately 12 miles north of the Coliseum. Camper/trailer facilities are available at Wiedemann Park. Located on 55 acres with two lakes, the park provides camping space for RV's or tents, complete with electrical hookups, water, sanitary dump and restrooms. The Kansas Coliseum is located at I-135 and Exit 17. In order to help you, the following are recommendations on how to get here if you are coming from the four corners: **North (I-70):** I-135 south to exit 17 **Northeast:** South on I-35 (Turnpike) to Highway 254 (El Dorado exit), then west to I-135, north to Exit 17; **East: I-35 (Turnpike)** to Highway 54 (Kellogg) exit, east on Kellogg to I-135, north to exit 17; **South: I-35 (Turnpike)** to K-15 exit (merge onto I-135), north to exit 17; **West: Highway 54 (Kellogg)** to I-135, north to exit 17. LOCATION OF CLASSES: The management reserves the right to hold classes, or portions of classes, in any ring other than in the main ring if deemed necessary.

LOOSE HORSES: Loose horses caught on the show grounds may be subject to a \$25.00 fine. The exhibitor must supply snap hooks for each stall that will prevent his horse from unlatching the stall.

MANNERS: Judges must eliminate from judging consideration any horse who shows aggression or discontent toward its handler, rider, or any person in the ring.

MEDAL CLASSES:

AHA Saddle Seat Medal class. (1) In addition to the rail work, all contestants are required to perform two or more individual tests from USEF Tests 1-15 or EC equivalent. Markers shall not be used.

AHA Reining Seat Medal class. (1) All contestants are required to perform a Reining pattern as outlined in USEF Reining, or EC equivalent. (Res 25-06) . (2) Dropping of bits is optional with the judge but if called for in the ring, assistance, if necessary, may be had from one of the ring officials. (3) Reins shall not be removed from the horse's neck while inspecting bits. (4) In an AHA Reining Seat Medal class an off pattern rider is eliminated and is not eligible to win a medal or ribbon. (5) The prescribed AHA Reining Seat Equitation Score Sheet must be used and posted in accordance with USEF rule AR199.5. (Res.25-06). (6) Numbers must be worn on the rider's back or in the case of reining seat equitation on the left side of the saddle pad and must be clearly visible at all times when in competition. See USEF rule EQ103.6. (Res. 8/07).

AHA Hunter Seat Not to Jump Medal class. (1) In addition to rail work, all contestants are required to perform two or more individual tests from USEF AR217 1-4 & sub chapter 2 (EQ113).

AHA Western Horsemanship Medal class. (1) In addition to rail work, all contestants are required to perform a minimum of four tests from USEF AR224. (BOD 5/06)

MEMBERSHIP: Each participant at an AHA Recognized Show, Division or Event must submit a valid AHA Competition Card, join AHA (Membership with Competition Card) at the show or pay a \$30 Single Event Membership fee per person. (Refer to Article 705, Res. 5-02, Article 302.3) (BOD 8/08)

MOTORIZED VEHICLES: Individuals who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. All operators of motorized vehicles on the competition grounds must have in their possession their official driver's license issued by their state of residence while operating said vehicle. Individuals who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. Violations of this rule will be cause for sanctions against the parent(s) or guardian(s) of a minor, the adult individual and/or trainer(s) of the individual committing the offense. Penalties may include exclusion of the parent(s), or guardian(s) of the minor, the adult individual and/or the trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Rule 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

NO SMOKING RULE: There is no smoking allowed indoors in any of the facilities of the Kansas Coliseum. Tickets can be issued to people who break this law.

NOVICE HORSE/RIDER: A Novice Horse/Rider class is open to horses/riders that have not won three (3) first place ribbons at Regular Member Shows of USEF or the Canadian Equestrian Federation in the particular performance division in which they are shown. A Novice entry is such from the date of the closing of entries for this show.

NUMBER OF ENTRIES IN EACH CLASS: Any class with less than four entries may at the discretion of the Show Committee, be combined with another class or canceled. The exhibitors in the class(es) will be notified accordingly. Large classes may be divided and conducted in two separate classes with duplicate prizes and awards, except in Championship Performance classes.

WALK/TROT: Walk/Trot riders in pleasure and equitation must never have been judged in a class at a recognized or non-recognized show that requires a canter/lope.

CHAMPIONSHIPS: Performance Championships in the Arabian Division to be held in accordance with Article 334. To be eligible, horses must have been entered, shown and judged in a designated qualifying class in the appropriate performance section.

PETS: All pets must be confined or held on a leash at all times. Tying pets in the alleyways between stall complexes is not allowed. Any loose animal may be picked up for confinement by County Animal Control persons at any time and without notice of any kind.

PREMIUM PAYMENT: Premiums will be paid by check not later than 30 days after the show, if accounts are paid in full.

Ribbons will be awarded as follows:

HALTER : Ribbons through 6th place. No payback.

Neck ribbon for Champion and Reserve. No payback.

No payback classes (Equitation, Medal, Leadline, Walk/Trot, and Showmanship) Ribbons to 6th place.

JUNIOR TO RIDE PERFORMANCE: Ribbons through 6th place. Payback.

CHAMPIONSHIP JR. EXHIBITOR: Ribbons through 6th place. Payback.

AHA MEDAL: Medal & ribbon through 8th place. No Payback.

PERFORMANCE: Ribbons through 6th place. Payback.

CHAMPIONSHIP: Ribbons through 6th place. Payback.

NOTICE: If fewer than six entries are shown in a class, payback will be adjusted as follows:

Internal Revenue Service - 1990 – Internal Revenue Code Form 1099 – Misc. Exhibitors receiving at least \$600 in prizes and awards by KAHS must be issued a 1099-Misc. Persons furnishing their tax payer ID number become subject to withholding at a 20 percent rate on payments required to be reported.

ALL 1ST, 2ND, & 3RD PLACE WINNERS IN QUALIFYING CLASSES MUST SHOW BACK IN THE RESPECTIVE CHAMPIONSHIP CLASSES OR FORFEIT ALL MONIES AND AWARDS. If an exhibitor or trainer qualifies more than one horse for a Championship he can elect to show only one without forfeiting winnings. (You must inform the Show Secretary in writing at the show if you elect to do this).

Federal regulations require owner's social security number or tax ID number for each horse. Show payback will be paid to the owner/agent by the Show Secretary after verification of placing and show back entries. Payback not paid at the show will be mailed 30 days after close of the show. Payback checks will not be cashed by the show office. However, checks will be received against additional show fees. All payback checks will be voided after 60 days

PROTESTS: A protest may be filed as set forth in USEF Rule Book.

REFUNDS: Request for refunds must be received in horse show office with a veterinarian certificate. Entry fees only minus a \$25.00 office charge will be refunded.

RETURNED CHECKS: No checks will be processed through the bank a second time. A charge of \$30.00 will be made for returned checks. To retain entries, funds must be paid by money order, cashier's check, or cash. In the event that a check is returned after the completion of the show, it will be handled in accordance with USEF Rule Book. **NOTE: Issuing a bad check is a criminal offense under Kansas Law. Prosecution may result in a fine of twice the amount of the insufficient funds check plus court costs and attorney's fees, if incurred.**

SCRATCHES: Any exhibitor or agent who fails to notify the horse show office to scratch an entry at least two (2) hours prior to the start of the session will be charged a fine of \$25.00 per class.

SHARP CONTAINERS: Sharp containers will be placed every fifty occupied stalls for the disposal of needles and other disposable sharp instruments in convenient locations in barns housing competition horses. These containers when full will be disposed of properly. Competition management may fine any individuals including trainer, owner, exhibitors or their agents up to \$100.0 for improper disposal of needles or other sharp disposable instruments. Per USEF Rule Book

SHAVINGS: May be purchased for \$6.50 a bag if ordered by entry deadline or \$7.00 a bag at the show.

SHOEING REGULATIONS/HOOF INSPECTION: Maximum length of toe and maximum weight of shoe in addition to pads are governed by USEF Rule Book Shoeing Regulation.

SHOW OFFICE HOURS: The show office will be open Thursday, from 2:00 p.m. to 10:00 p.m. on the show days, Friday, Saturday, and Sunday, the office will be open from one hour before the first class until after the last class of the day.

STALLS: Box stalls, approximately 10' x 10' with doors, are on concrete and will be \$85.00 for the entire show. Stalls will be available at noon March 24, 2010. EARLY ARRIVAL is available March 23, 2010 at 8:00am. Early Arrival fee is \$20.00 per horse. All horses must have a stall and only horses exhibiting at this show are to be stabled. Management reserves the right to limit the number of tack stalls per stable depending on the number of entries. No bedding is furnished with the stalls. Stalls will be assigned according to date entries are received. If you wish to stable with someone, please note that on your stall request and mail your entries together. Stall decorations are encouraged. However, if stalls are dismantled in any way, they must be reassembled.

SUBSTITUTE RULE: If a horse is excused by a Veterinarian's Certificate as unfit to show prior to the closing date, March 12, 2010, another horse from the same stable may be permitted except as provided in USEF Rule Book.

TELEPHONE: The Show Office telephone is 316-755-2560 for incoming calls.

TIME OUT: In all performance and breeding halter classes, an exhibitor is entitled to only one time-out per class.

TRAINING AIDS: Whips longer than six (6) feet are not allowed at ringside or warm-up areas. Explosives and fire extinguishers used as training aids are prohibited in the show grounds before, during, or after the show. Fire extinguishers will be confiscated and offenders will be reported to USEF. **NO ATTENTION-GETTING DEVICES ARE ALLOWED IN WARM-UP RING OR SHOW RING.**

VETERINARIAN: A number will be posted for an on-call Veterinarian at the Show Office. Exhibitors are responsible directly to them for their services and method of payment.

VETERINARIAN INSPECTION: All animals are subject to a physical inspection by the Show Veterinarian at the discretion of the Show Committee.

WITHDRAWAL: All withdrawals of entries in part or total must be done by written cancellation prior to closing of entries. After closing no fees shall refunded unless withdrawal is accompanied by a Veterinarian's Certificate, or in the case of an exhibitor, a Doctor's certificate, in which case, at the discretion of the Show Committee, all or part of the entry fees may be refunded. No refunds once a horse has been shown.

EXHIBITORS ARE ADVISED TO REFER TO THE CURRENT USEF RULE BOOK FOR RULE CLARIFICATIONS.
